**VIII. ORDERS OF THE COURT**

Counsel shall exchange a list of any additional witnesses or exhibits to opposing counsel not later than ten (10) days prior to settlement conference or twenty (20) days prior to trial. A Domestic Relations Affidavit shall be filed with the Clerk of the Court not later than twenty (20) days before the trial in this action and a copy sent to opposing counsel. Except by consent of the parties or by order of the Court to prevent manifest injustice; exhibits, witnesses and professional/expert reports not listed nor provided as set forth herein shall not be admitted into evidence nor testimony allowed except in proper rebuttal. Either party may offer the testimony of witnesses listed by the other and either party may offer into evidence exhibits listed by the other.

This Pretrial Order shall supercede all pleadings, shall control the subsequent course of this case and shall not be modified except by consent of the parties with Court approval or by order by the Court on its own Motion to prevent manifest injustice.

The Court finds that this case is at issue; however, all discovery may not be complete. Completion of any additional discovery will not delay the trial of this case.

The case will be tried to the District Court in Wichita, Kansas.
