# DOCUMENTS TO BE SENT WITH SUMMONS AND ALIAS SUMMONS IN EVICTION AND COLLECTION CASES

This order applies to all cases with the designation LM effective Monday, August 24, 2020.

All plaintiffs in Limited Action (LM) EVICTION CASES must include one additional document with the Petition and Summons and Alias Summons to be served upon defendants. The additional document is the Clerk of the District Court's MEMO to defendants in Eviction cases.

All plaintiffs in Limited Action (LM) COLLECTION CASES must include two additional documents with the Petition and Summons and Alias Summons to be served upon defendants. These are: 1) a CV LM Defendant Information Sheet with Instructions; and 2) the Clerk of the District Court's Memo to defendants in Collection cases.

This order is effective Monday, August 24, 2020 and remains in effect until further order of the Court.
